Parent Requesting an IRS Verification of Nonfiling Letter

An IRS Verification of Nonfiling Letter provides proof that the IRS has no record of a filed Form 1040 for the year you requested. Non Tax filers can request an IRS Verification of Nonfiling of their 2021 tax return status, free of charge, from the IRS by following the steps below:

Paper Request Form IRS Form 4506T

Download IRS Form 4506T at <https://www.irs.gov/pub/irs-pdf/f4506t.pdf>

- x Complete lines 1 to 4 with the nonfilers information, following the instructions on page 2 of the form.
- x Line 5: Leave this section blank unless you have a Customer File Number
- x Line 6: Leave this section blank.
- x Line 7: Select the checkbox on the right hand side for Verification of Nonfiling.
- x Line 8: Leave this section blank.
- x Line 9: Year or period requested field, enter "12/2021".
- x The nonfiler must sign and date the form and enter their telephone number. Only one signature is required when requesting a joint IRS Verification of Nonfiling Letter.
- x Be sure to review and check the box above the signature section.
- x Mail or fax the completed IRS Form 4506T to the address (or FAX number) provided on page 2 of Form 4506T. If the 4506T information is successfully validated, you can expect to receive a paper IRS Verification of Nonfiling Letter at the address provided on their request within 5 to 10 days.

Once you have received your Verification of Nonfiling letter, attach it to your completed and signed 2023-2024 Parent NonTax Filer Statement and fax or mail both documents to the Stevenson University Financial Aid office.
